- ★ Traders World does not cash checks or provide change.
- ★ Traders World is not responsible for vendors merchandise.
- ★ Traders World reserves the right to refuse admission to any seller and inspect all merchandise. Traders World does not permit the display, sale, or trade of COUNTERFEIT MERCHANDISE. If you are engaged in any above activities at Traders World you will be permanently removed from the market.
- ★ No Guns for sale, trade, or display.
